Attention Points

General

Your registration to the 30th Montreal meeting is only final when you have paid the registration fees **and** sign the disclaimer document regarding the event.

Arrival at the hotel on September 1st, 2016

When you arrive in Dinant, please go directly to the Hotel "Castel de Pont à Lesse" for the check in and to validate your registration. Direction to the hotel will be indicated after you exit the motorways. When you are installed at the hotel, you take the car and go to Dinant downtown following instructions of the roadbook received during the registration.

In Dinant, you will be directed to a parking specially booked for the event.

Mettet Racetrack

If you want to go on the Mettet Racetrack, you must fill in and sign the "Waiver of appeal" document. This document will be controlled at the track entrance. Without that entrance to the circuit will be forbidden.

Note that a personal insurance can be subscribed at the circuit for 17 €. It is not mandatory but advised.

Helmet is not mandatory but advised.

Trip on the "SAX" boat

This excursion will take place just after the Mettet racetrack. The boat cannot leave as long as all participants have embarked. So I insist that every Montreal owner leaves the circuit on time to avoid that the boarding on the ship lasts too long.


Parking

DISCLAIMER (RESPONSIBILITIES AND EXCLUSION OF LIABILITY) -english-

The Alfa Montreal Meeting 2016 from 1st to 4th September 2016 is already the 30th annual meeting of the Montreal Registry Europe. The Meeting includes several common activities of the participants, including also one or more tourist trips by car to various destinations. These trips are no skill rides and no speed races.

Possibly named departure times and routes in the program are non-binding suggestions. The arrival times at the destinations of these trips are only binding to participate in the respective program points. Xavier Lemaire is only organizer of the framework of this year's Meeting.

a) Responsibility:

The participants (drivers, passengers, car-owners and -keepers) take part in the event at their own risk. They shall bear sole responsibility under civil and criminal law for all damage caused by themselves, or by the vehicle which they are using.

b) Exclusion of liability:

With the application the participants (drivers, passengers, car-owners and -keepers) waive all rights of action or of recourse for all accidents or damages suffered in connection with the Alfa Montreal Meeting 2016 against the organizers and their representatives and assistants, authorities, companies and any other persons

associated with the organization of the Meeting. The above exclusion of liability and waiver of recourse does not apply to damage

The above exclusion of liability and waiver of recourse does not apply to damages arising from harm to life, body or health due to a deliberate or negligent breach of duty including deliberate or negligent breach of duty

by a legal representative or agent of the group of persons excluded from liability, or to other damages due to a

deliberate or grossly negligent breach of duty, including deliberate or grossly negligent breach of duty by a legal representative or agent of the group of persons excluded from liability. This exclusion of liability applies also to any damages to the vehicle caused by attaching race numbers and event code (rally signs). The registrant ensures that he is authorized to submit the declarations for any additional passengers, and that he is the owner of the vehicle/s used by him at the Meeting or is authorized by the owner/s, to submit the declaration. Should this obligation fail to be met, the participant hereby indemnifies the foregoing group of persons against any claims for compensation brought by additional passengers, the vehicle's owner or a third party, except for damages arising from harm to life, body or health due to a deliberate or negligent breach of duty including deliberate or negligent breach of duty by a legal representative or agent of the group of persons excluded from liability, or to other damages due to a deliberate or grossly negligent breach of duty, including deliberate or grossly negligent breach of duty by a legal representative or agent of the group of persons excluded from liability.

c) Responsibility of the organizer, Xavier Lemaire:

The organizers hereby reserve the right, to make such amendments to the program as are required as a result of force majeure or for reasons of security or as have been ordered by government authorities or to cancel the Meeting should this be due to extraordinary circumstances, without incurring any duty of compensation. In case of breaking off the Meeting due to force majeure or safety reasons no refund of the fees or other compensation claims are made. This agreement shall be effective upon registration. In addition, the organizer is liable only so far as exclusion of liability is not agreed.

d) Insurances:

The organizer shall take out a liability insurance policy for operators.

By registering, everyone who participates in the Meeting subjects, without limitation, these terms and possibly following additions or changes. Each participant has to take care of the necessary insurance for his vehicle and, where appropriate, for the passengers. Each participant is responsible for himself and for the traffic safety of his vehicle and the compliance with the relevant road traffic regulations (StVO Road Traffic Regulations, StVZO Road Traffic Licensing Regulations) and is committed to a driving style adapted to the respective conditions.
